

## Contest terms and conditions

### *"Holiday with a season pass"*

#### 1. Contest organiser

The *"Holiday with a season pass"* contest (hereinafter referred to as **"Contest"**) is organised by the GOPASS a.s. company, with the registered office at Demänovská Dolina 72, Company number: 53 824 466, registered in the Commercial Register of District Court Žilina, Section: Sa, Insertion No.: 11039/L (hereinafter referred to as **"Organiser"**).

The Contest Organiser is hereby publishing these Contest Terms and Conditions (hereinafter referred to as **"Rules"**). The main purpose of the Contest is to support, promote and develop the image of the company in social media.

The conditions of participation and the Contest itself are governed only by these Rules, which define the conditions of participation in the Contest. Any change to the Rules and the conditions of the Contest made by the Organiser must be done in writing in the form of an addendum.

#### 2. Conditions of participation in the Contest

Any **natural person** that fulfils the Contest conditions (hereinafter referred to as **"Participant"**) can participate in the Contest. Employees of the Contest Organiser and persons who are close to them; employees and persons who are close to employees of individuals that are linked to the Organiser personally or via property relations or who are close to promotion and advertising agencies that perform activities related to the Contest cannot participate in the Contest. Persons mentioned in § 116 Act No. 40/1964 Coll. Civil Code as subsequently amended and persons who share household with them (§ 115 Act No. 40/1964 Coll. Civil Code as subsequently amended) are considered close persons as far as the Contest is concerned.

If the Contest is won by a person who has been forbidden to take part, they shall not be given the winning prize. The same applies if the Organiser finds out about or has reasonable suspicion of fraud and/or unfair practises related to a participant or another person that might have helped the respective participant win the prize. If a person who has been forbidden to take part in the Contest has already been given the winning prize, they are obliged to return the prize to the Organiser.

The Organiser reserves the right to exclude any Participant from the Contest at Organiser's sole discretion and in any phase of the Contest if the Participant's behaviour and actions may stain the reputation of the Organiser or affect the rights or legitimate interests of third parties in any way.

The Organiser reserves the right to exclude any Participant from the Contest in case they are suspected of violating the Rules or acting against the Rules.

#### 3. Contest duration

The Contest takes place **from 1<sup>st</sup> September 2022 to 18<sup>th</sup> September 2022.**

#### **4. Contest rules**

Every Participant who buys a PREMIUM Smart Season Pass 2022/2023 during the Contest duration joins the Contest automatically.

#### **5. Contest winning prizes**

Only one person that fulfils the Contest conditions specified in Art. 4 – Contest rules can win the Contest. The winner is going to be drawn on 19<sup>th</sup> September 2022 – by a random winner generator from all Contest Participants who bought a PREMIUM Smart Season Pass 2022/2023 during the Contest duration.

#### **6. Collecting of the winning prize – place, procedure and period**

The Contest winner will be informed about their victory via their email address that was used to buy their PREMIUM Smart Season Pass 2022/2023 in the [www.gopass.travel](http://www.gopass.travel) online shop. To win the prize specified in Art 5 items a) and c) of the Rules, the respective person must be registered for the Gopass programme on [www.gopass.travel](http://www.gopass.travel). The way how the winning prize is delivered or sent shall be discussed between the Organiser and the winner.

Shall any winner not be interested in receiving the winning prize, refuse to take the prize, fail to meet the rules, or shall the Organiser fail to contact the winner within two (2) working days after the Contest is evaluated and the winner is announced, another Participant who has fulfilled the terms specified in Art. 4 of the Rules shall be drawn by the Organiser.

The Contest results are final and cannot be appealed against. The winning prize is non-transferable, cannot be changed as the winner wishes and the winner is not entitled to ask for financial compensation instead of the prize. In accordance with § 845 Act No. 40/1964 Coll. Civil Code, the prize is not enforceable through the court.

#### **7. Special provisions**

The Contest Organiser reserves the right to decide about any terms and conditions of the Contest at their own discretion and the right to limit, postpone, interrupt, amend or cancel the Contest at any time due to specific reasons. The Organiser is not responsible for any technical or programme errors that arise during the Contest.

The winning prize can be subject to taxation in accordance with Act No. 595/2003 Coll. on Income Tax as subsequently amended. The tax as well as other financial duties that can be related to receiving a winning prize shall be paid by the winner in full amount as defined by the law.

## **8. Protection of personal data**

The Contest Organiser, i.e. the operator, i.e. GOPASS a.s., with the registered office at Demänovská Dolina 72, Company number: 53 824 466, registered in the Commercial Register of District Court Žilina, Section: Sa, Insertion No.: 11039/L processes personal data in accordance with the general binding laws of the Slovak Republic, mainly the Regulation (General Data Protection Regulation, hereinafter referred to as "GDPR") and Act No. 18/2018 Coll. on Protection of Personal Data (hereinafter referred to as "**Act**").

Personal data of individual Contest Participants are processed by the operator for the following Contest purposes:

1. name, surname, email address for the purpose of sending and delivering the winning prize to the winner based on a legitimate interest and the agreement where the person in question is considered to be a party to the agreement.

The personal data are processed for the period which is required to fulfil the above mentioned purpose, however, no longer than for one (1) year after the respective data have been provided. The personal data are processed for the above mentioned purpose of evaluating, informing the winner and delivering the winning prize in the Contest as well as informing the public about the winner.

## **9. Final provisions**

Ignorance of these Contest Rules does not entitle anybody to file a complaint and such complaint shall not be taken into account.

By taking part in the Contest, the Participants agree with the Contest Rules. The winning prize shall not be given to a Participant who does not agree with these Rules without reservation and does not meet all conditions resulting from these Rules.
