This Addendum to the Terms and Conditions of the Gopass SKI Season Pass and the Gopass SKI Season Pass + Fast Pass Wave 1, and the Terms and Conditions of the Gopass SKI Season Pass and the Gopass SKI Season Pass + Fast Pass Wave 2 (hereinafter referred to as “**Terms and Conditions**“) supplement the Terms and Conditions that are effective for Wave 1 from 27.3.2024 and for Wave 2 from 1.7.2024, apply to the 2024/2025 winter season, are defined by the **GOPASS SE** company, with the registered office at: Komořanská 326/63, Modřany, 143 00 Prague, Czech Republic, Company number: 171 07 148, registered in the Commercial Register of Municipal Court Prague, file Nr. In Article 6 of the Terms and Conditions, point 6.1 shall be changed in its entirety as follows:

6.1 *If any Gopass SKI Season Pass holder or Gopass SKI Season Pass + Fast Pass holder buys products or services in the below listed gastronomy facilities in resorts operated by the TMR company in Slovakia (Jasná: Apreski Lúčky, Apreski Funi bar, Apreski Fis bar, Apreski Krupová, Crystal bar, Happy End, Rotunda, Habarka, Bernardino Burger, Snack bar Rovná Hoľa, Reštaurácia Kosodrevina, Jasná Mountain Food, Energy Bar Chopok; Tatranská Lomnica: Humno Restaurant, Apreski bar, Restaurant Pizza Pasta, Retrostation Restaurant, Panorama Restaurant Skalnaté pleso, Café Panorama, Kaviareň Dedo; Starý Smokovec: Restaurant Hrebienok, in Skiareal Špindlerův Mlýn (Après Ski bar Hromovka, Quattro bar, Restaurace Stadion, Restaurace Na Pláni, Restaurace Medvědin, Bistro U lanovky), in Ještěd (Après-ski bar Nová Skalka, Restaurace Můstek, Bistro Horní Skalka, Bistro Pláně), in Szczyrkowski Ośrodek Narciarski (Aprèski Gondola, Grill bar Gondola, Restauracja Kuflonka), in Mölltaler Gletscher (Bergrestaurant Panorama Eisse, Sonnblick Bar, Mölli Bar), or in Motion facilities operated by the TMR company in Slovakia (Jasná: Lúčky rental, Lúčky service, Záhradky rental, Biela Pút rental, Jasná Grand Jet service, Grand Hotel rental, Damian Jasná Hotel rental, Krupová rental, Krupová service); Tatranská Lomnica: Tatry Motion Shop & Rent Tatranská Lomnica, Tatry Motion Shop Skalnaté pleso, Intersport Rent Tatranská Lomnica; Starý Smokovec: Tatry Motion Shop & Rent Starý Smokovec, Tatry Motion Shop Hrebienok); in Skiareal Špindlerův Mlýn (Spindl Motion Rental Hromovka, Spindl Motion Rental Svatý Petr, Spindl Motion Rental Medvědin, Spindl Motion RENTAL Misečky, Skiservis Svatý Petr); in Ještěd (Ještěd Motion Shop & Rental) during the validity period of their Gopass SKI Season Pass or Gopass SKI Season Pass + Fast Pass, they will earn 15% goX cashback on each purchase based on the general terms and conditions of the Gopass programme.*

Other provisions of the Terms and Conditions not specified in this Addendum are effective and in force as amended by the Terms and Conditions.

This Addendum which amends and supplements the Terms and Conditions becomes effective and enters into force on 1.11.2024 and the Terms and Conditions as amended by this Addendum are effective and in force from 1.11.2024 to 30.4.2025, or to the end of the 2024/2025 winter season depending on the weather and the snow conditions and the decision of the operator if this happens sooner than on 30.4.2025, or during the validity period of Gopass SKI Season Passes and Gopass SKI Season Passes + Fast Passes Wave 1 and Gopass SKI Season Passes and Gopass SKI Season Passes + Fast Passes Wave 2 in individual resorts.
