This Addendum to the Terms and Conditions of the Premium Smart Season Pass and Premium Smart Season Pass + Fast Pass Wave 1 and the Terms and Conditions of the Premium Smart Season Pass and Premium Smart Season Pass + Fast Pass Wave 2 and the Terms and Conditions of the Premium Smart Season Pass and Premium Smart Season Pass + Fast Pass Wave 3 and the Terms and Conditions of the Premium Smart Season Pass and Premium Smart Season Pass + Fast Pass Wave 4 (hereinafter referred to as “**Terms and Conditions**“) supplement the Terms and Conditions that are effective for Wave 1 from 11/4/2023, for Wave 2 from 1/6/2023, for Wave 3 from 1/10/2023 and for Wave 4 from 1/12/2023, apply to the 2023/2024 winter season, are defined by the **GOPASS SE** company, with the registered office at: Primátorská 296/38, 180 00 Prague 8 – Libeň, Czech Republic, Company number: 171 07 148, registered in the Commercial Register of Municipal Court Prague, file Nr. In Article 4 of the Terms and Conditions, the following item 4.3 shall be added after item 4.2:

4.3 As the Women's FIS Alpine Ski World Cup is organised and takes place in the Jasná resort during the 2023/2024 winter season on 20/1/2024 and 21/1/2024, Premium Smart Season Passes 1 and Premium Smart Season Passes 1 + Fast Passes; Premium Smart Season Passes 2 and Premium Smart Season Passes 2 + Fast Passes; Premium Smart Season Passes 3 and Premium Smart Season Passes 3 + Fast Passes; and Premium Smart Season Passes 4 and Premium Smart Season Passes 4 + Fast Passes can be used on the days above only if all the conditions below are met:

4.3.1 Every Premium Smart Season Pass 1 or Premium Smart Season Pass 1 + Fast Pass or Premium Smart Season Pass 2 or Premium Smart Season Pass 2 + Fast Pass or Premium Smart Season Pass 3 or Premium Smart Season Pass 3 + Fast Pass or Premium Smart Season Pass 4 or Premium Smart Season Pass 4 + Fast Pass holder has to activate the voucher(s) with two (2) 1-day ski passes from the GOPASS SE company in the GOPASS vouchers/discounts section in their GOPASS account. If the vouchers are activated, they enable the respective Premium Smart Season Pass 1 or Premium Smart Season Pass 1 + Fast Pass or Premium Smart Season Pass 2 or Premium Smart Season Pass 2 + Fast Pass or Premium Smart Season Pass 3 or Premium Smart Season Pass 3 + Fast Pass or Premium Smart Season Pass 4 or Premium Smart Season Pass 4 + Fast Pass holder to use the services of the Jasná resort on 20/1/2024 and/or on 21/1/2024 (when the Women's FIS Alpine Ski World Cup takes place) depending on whether they activate the vouchers for both days or only one voucher for 20/1/2024 or 21/1/2024.

4.3.2 If any Premium Smart Season Pass 1 or Premium Smart Season Pass 1 + Fast Pass or Premium Smart Season Pass 2 or Premium Smart Season Pass 2 + Fast Pass or Premium Smart Season Pass 3 or Premium Smart Season Pass 3 + Fast Pass or Premium Smart Season Pass 4 or Premium Smart Season Pass 4 + Fast Pass holder wants to use the services of the Jasná resort on 20/1/2024 and/or on 21/1/2024, they must activate their voucher(s) until 18/1/2024 (including). From 19/1/2024 0:00 a.m., the voucher activation is not possible anymore!

Every Premium Smart Season Pass 1 or Premium Smart Season Pass 1 + Fast Pass or Premium Smart Season Pass 2 or Premium Smart Season Pass 2 + Fast Pass or Premium Smart Season Pass 3 or Premium Smart Season Pass 3 + Fast Pass or Premium Smart Season Pass 4 or Premium Smart Season Pass 4 + Fast Pass holder can decide whether they activate their voucher(s) or not.

The operation of other resorts where Premium Smart Season Passes 1 and Premium Smart Season Passes 1 + Fast Passes; Premium Smart Season Passes 2 and Premium Smart Season Passes 2 + Fast Passes; Premium Smart Season Passes 3 and Premium Smart Season Passes 3 + Fast Passes; Premium Smart Season Passes 4 and Premium Smart Season Passes 4 + Fast Passes are valid shall not be affected by this regulation and is governed by the general rules of these Terms and Conditions and the General Terms and Conditions that are in force in individual resorts.

Other provisions of the Terms and Conditions not specified in this Addendum are effective and in force as amended by the Terms and Conditions.

This Addendum which amends and supplements the Terms and Conditions becomes effective and enters into force on 11/12/2023 and the Terms and Conditions as amended by this Addendum are effective and in force from 11/12/2023 to 30/4/2024, or to the end of the 2023/2024 winter season depending on the weather and the snow conditions and the decision of the operator if this happens sooner than on 30/4/2023 or during the validity period of Premium Smart Season Passes 1 and Premium Smart Season Passes 1 + Fast Passes; Premium Smart Season Passes 2 and Premium Smart Season Passes 2 + Fast Passes; Premium Smart Season Passes 3 and Premium Smart Season Passes 3 + Fast Passes; and Premium Smart Season Passes 4 and Premium Smart Season Passes 4 + Fast Passes in individual resorts.
